

COSTS AND CONDITIONS

AIRFARE: Airfare to Fayetteville, AR and return home is not included. As a rule, it is wise to refrain from purchasing non-refundable airfare until the minimum number of participants has been met.

TOUR SIZE: Minimum 10, Maximum 15

TOUR INCLUDES: 2 nights accommodation at 21c, Bentonville AR, 2 breakfasts, 1 lunch, 2 dinners, guided visits and tours, hotel transfers to airport, restaurant service charges and taxes, coordination and administration

TOUR EXCLUDES: Travel to Bentonville, AR, meals not specified in the itinerary, personal items such as laundry, email, fax or telephone calls, alcoholic beverages, room service, medical expenses, travel insurance, optional extensions or deviations from the scheduled tour.

Georgia O'Keeffe comes to the Crystal Bridges Museum

Art, Food and Nature combine to make this trip to Arkansas an experience to remember. The Georgia O'Keeffe exhibit of more than 3 dozen works will dazzle. Dining at the Hive at 21c and at Table Mesa will delight the epicurean yearning. More than 3.5 miles of trails wind through the Museum's 120-acre site, providing guests with access to the beautiful Ozark landscape. Designed to spark the imagination, the trails help guests form connections to the land and its history, as well as enjoy outdoor artworks.

This three-day, two-night trip includes two nights lodging at 21c, 2 breakfasts, 1 lunch, 2 dinners, guided tours and airport shuttles.



Crystal Bridges takes its name from a nearby natural spring and the bridge construction incorporated in the building, designed by world-renowned architect Moshe Safdie. Guest amenities include a restaurant on a glass-enclosed bridge overlooking the ponds, a Museum Store designed by architect Marlon Blackwell, and a library featuring more than 50,000 volumes of art reference material. Sculpture and walking trails link the Museum's 120-acre park to downtown Bentonville, Arkansas.

Crystal Bridges was founded in 2005 by the Walton Family Foundation as a nonprofit charitable organization for all to enjoy. Philanthropist and arts patron Alice Walton chairs the Museum's board of directors.

Itinerary

Sunday evening dinner will be served at the Hive, located at the 21c. Then you will have time for an evening stroll along the trail to view Bucky Ball at the entrance of Crystal Bridges Museum (CBM). On Monday, following breakfast, enjoy the surrounding trails and arrive for a guided tour of the Bachman-Wilson House. Lunch will be at CBM, followed by a guided tour of the Georgia O'Keeffe exhibit. There will be time to tour other collections at the museum and free time until dinner at Table Mesa. In the evening you can walk the trail to view the Sky Space Structure. On Tuesday, following breakfast you will have a tour of the Wal-Mart Museum, before leaving for the airport and the return flight home.



Lodging at the 21c

Located on the northeast corner of the Bentonville town square and a short walk to Crystal Bridges Museum of American Art, 21c Museum Hotel Bentonville is a 104-room boutique hotel, contemporary art museum, cultural center and home to The Hive restaurant, led by executive chef Matthew McClure.
